

WHEREAS, an application has been made by **Robin Strickland d/b/a Apollo Limousine Service**, for a certification of public convenience and necessity for the operation of nine(9)additional limousines in the City of Huntsville, and

WHEREAS, Ordinance No. 75-243 provides for the publication of a notice that such application has been made and setting a date for a public hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Huntsville, Alabama, as follows:

1. That the intent of the City Council of the City of Huntsville, Alabama to consider whether a public convenience and necessity justifies the issuance of a limousine license to **Robin Strickland d/b/a Apollo Limousine Service**, for the operation of nine (9) additional limousines is hereby declared.
2. That the City Council of the City of Huntsville shall meet at 6:00 P.M. on the 28th day of February, 2013, at the Council Hall or at such other place announced by the Council in the City of Huntsville for the purpose of holding a public hearing on the question of whether public convenience and necessity justifies the issuance of a limousine license to **Robin Strickland d/b/a Apollo Limousine Service**, for the operation of nine (9)additional limousines, at which time all parties may appear in person, by agent, or by attorney for the purpose of voicing objections or remonstrations.
3. That this resolution shall be published in the Huntsville Times, a newspaper of general circulation within the City of Huntsville, Alabama, said publication to be not less than seven days prior to the date of this hearing.
