BE IT RESOLVED by the City Council of the City of Huntsville, Alabama, that the Mayor be, and he is hereby authorized to enter into a Modification No. 16 to Supplemental Development Agreement by and between the City of Huntsville and LW Redstone Company, LLC, on behalf of the City of Huntsville, a municipal corporation in the State of Alabama, which said agreement is substantially in words and figures similar to that certain document attached hereto and identified as "Modification No. 16 to Supplemental Development Agreement TIF5 Series 2010-B between the City of Huntsville and LW Redstone Company, LLC," consisting of three (3) pages and the date of March 14, 2013, appearing on the margin of the first page, together with the signature of the President or President Pro Tem of the City Council, an executed copy of said document being permanently kept on file in the Office of the City Clerk-Treasurer of the City of Huntsville, Alabama.

MODIFICATION NO. 16 TO SUPPLEMENTAL DEVELOPMENT AGREEMENT TIF5 – SERIES 2010-B TO ANNEXATION AND DEVELOPMENT AGREEMENT BETWEEN THE CITY OF HUNTSVILLE AND LW REDSTONE COMPANY, LLC, AS ADOPTED AND APPROVED BY RESOLUTION NO. 10-892 ON OCTOBER 28TH, 2010 AND AS AMENDED BY MODIFICATIONS NO. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15.

MODIFICATION No. 16

Pursuant to Section 7.3 of the Annexation and Development Agreement dated March 25, 2010, (“Agreement”), between THE CITY OF HUNTSVILLE, ALABAMA, a municipal corporation organized and existing pursuant to the laws of the State of Alabama (“City”) and L W REDSTONE COMPANY, LLC, a Delaware limited liability company (“Owner”), City and Owner enter into this Modification No. 16 to the Supplemental Development Agreement (SDA) TIF5 Series 2010-B, which was previously adopted and approved on October 28, 2010 and previously amended on May 12, 2011, June 23, 2011, July 14, August 11, August 25, 2011, September 22, 2011, December 15, 2011, January 26, 2012, March 22, 2012, May 24, 2012, June 14, 2012, September 13, 2012, December 6, 2012, January 10, 2013, and February 28, 2013 and hereby provide more specifically for the obligations of City and Owner. Modifications to Scope of Work and allocations within the \$20,000,000 Maximum Amount of the prior Supplemental Development Agreement referenced above are as follows:

1. Within Section B., ADD the following: “The amount of \$1,138,349.23 that was previously budgeted and funded for the contract with Reed Contracting Service, Inc. for Redstone Gateway, Package 1E-Rideous Road Interim Improvements, Project No. 65-11-SP08 needs to be increased by the amount of \$2,310.00 from Account No. 0506500-0811-2030 in order to add Change Order No. 3 for field directive #5 to repair/replace the existing emergency gate security loop at Gate #9. The revised total contract amount that is budgeted and funded for the total contract will now be \$1,140,659.23.”
2. Within Section B., ADD the following: “The amount of \$602,799.08 that was previously budgeted and funded for the contract with Vision Landscapes, Inc. for Redstone Gateway Extension, Market Street, and Overlook Road Relocation-Package 1F-4 Landscape, Irrigation and Hardscape, Project No. 65-11-SP22 needs to be increased by the amount of \$5,092.18 in order to add Change Order No. 1 for field directive #1 to add three (3)each trees and two (2)each irrigation zones between Package 1G and 1F-4 and add one (1) each bore at the center island on the north end of Market Street. The revised total contract amount that is budgeted and funded for the total contract will not be \$ 607,891.26.”
3. Within Section B. OWNER IMPROVEMENTS, the subsection entitled “ENGINEERING AND CONSTRUCTION COSTS TO BE DETERMINED,” the amount of \$233,435.83 allocated and budgeted for undefined engineering and construction costs is hereby decreased by a total of \$7,402.18 to \$226,033.65.

All other terms and conditions of the SDA TIF5-SERIES 2010-B, as previously modified, remain unchanged.
