MODIFICATION NO. 17 TO SUPPLEMENTAL DEVELOPMENT AGREEMENT TIF5 – SERIES 2010-B TO ANNEXATION AND DEVELOPMENT AGREEMENT BETWEEN THE CITY OF HUNTSVILLE AND LW REDSTONE COMPANY, LLC, AS ADOPTED AND APPROVED BY RESOLUTION NO. 10-892 ON OCTOBER 28TH, 2010 AND AS AMENDED BY MODIFICATIONS NO. 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15.

MODIFICATION No. 16

Pursuant to Section 7.3 of the Annexation and Development Agreement dated March 25, 2010, ("Agreement"), between THE CITY OF HUNTSVILLE, ALABAMA, a municipal corporation organized and existing pursuant to the laws of the State of Alabama ("City") and L W REDSTONE COMPANY, LLC, a Delaware limited liability company ("Owner"), City and Owner enter into this Modification No. 17 to the Supplemental Development Agreement (SDA) TIF5 Series 2010-B, which was previously adopted and approved on October 28, 2010 and previously amended on May 12, 2011, June 23, 2011, July 14, August 11, August 25, 2011, September 22, 2011, December 15, 2011, January 26, 2012, March 22, 2012, May 24, 2012, June 14, 2012, September 13, 2012, December 6, 2012, January 10, 2013, and February 28, 2013 and hereby provide more specifically for the obligations of City and Owner.

Modifications to Scope of Work and allocations within the \$20,000,000 Maximum Amount of the prior Supplemental Development Agreement referenced above are as follows:

1. Within Section 8., ADD the following: " The amount of \$28,726.00 is budgeted and funded from Account No. 05-6500-0811-2040 for a time and materials contract to be awarded to Skipper Consulting, Inc. in the Not-to-Exceed amount of \$28,726.00 for a Traffic Engineering Study for Traffic Analysis At Grade Improvements at the south side of the Rideout Road/I-565 Interchange, Project No. 65-13-SP28 . The area that is the subject of the study is Included In the denied access area of the Gateway project on Redstone Arsenal.
2. Within Section B. OWNER IMPROVEMENTS, the subsection entitled "ENGINEERING AND CONSTRUCTION COSTS TO BE DETERMINED," the amount of \$226,033.65 allocated and budgeted for undefined engineering and construction costs is hereby decreased by a total of \$28,726.00 to \$197,307.65.

All other terms and conditions of the SDA TIF5-SERIES 2010-B, as previously modified, remain unchanged.


