
More than thirty (30) days have passed since the issuance of the Notice of Final Assessment to Mama's Enterprises LLC DBA Mama's American Table reflecting that Mama's Enterprises LLC DBA Mama's American Table is indebted to the City of Huntsville for past-due liquor and sales taxes, interest and penalties in the amount of \$47,019.55 for the period in which said bond was in effect. Mama's Enterprises LLC DBA Mama's American Table has not responded to the Notice of Final Assessment.

**WHEREAS**, Platte River Insurance Company issued a surety bond in the amount of SIXTEEN THOUSAND AND 00/100 DOLLARS (\$16,000.00) for the payment of liquor and other taxes to Mama's Enterprises LLC DBA Mama's American Table.

**WHEREAS**, the Principal failed to pay taxes in the amount of FORTY SEVEN THOUSAND NINETEEN AND 55/100 DOLLARS (\$47,019.55) for the taxing period of December 2011 through August 2012; and

**WHEREAS**, the City Clerk-Treasurer's Office has made every possible effort to collect the taxes due from the Principal.

**WHEREAS**, pursuant to Res. 13-667, the City Council of the City of Huntsville, Alabama authorized the City Attorney to seek a forfeiture of the surety bond issues by Platte River Insurance Company.

**WHEREAS**, the correct amount of the bond is SIXTEEN THOUSAND AND 00/100 DOLLARS (\$16,000.00).

**NOW, THEREFORE, BE IT RESOLVED**, by the City Council of the City of Huntsville, Alabama, that the City Attorney's Office is hereby authorized, requested, and directed to seek a forfeiture of the surety bond issued by Platte River Insurance Company; and

**BE IT FURTHER RESOLVED** by the City Council of the City of Huntsville, Alabama, that the Mayor, upon payment by Platte River Insurance Company and in accordance with its bond, is hereby authorized, requested, and directed to execute a release and assignment agreement substantially in words and figures as Attachment "A", an executed copy of said document being permanently kept on file in the Office of the City Clerk-Treasurer of the City of Huntsville, Alabama.

KNOW ALL MEN BY THESE PRESENTS that the undersigned, for the sole consideration of SIXTEEN THOUSAND AND 00/100 DOLLARS (\$16,000.00) to be paid by Platte River Insurance Company from the bond of Mama's Enterprises LLC DBA Mama's American Table (Bond Number 41237656), to the City of Huntsville, Alabama, releases and discharges Platte River Insurance Company from the obligation of the bond to the extent of SIXTEEN THOUSAND AND 00/100 DOLLARS (\$16,000.00) received for the taxing period of June 2012 through January 2013.

In further consideration of payment of SIXTEEN THOUSAND AND 00/100 DOLLARS (\$16,000.00) of the above noted bond, the City of Huntsville, Alabama, hereby assigns to Platte River Insurance Company any claim the City of Huntsville, Alabama, may have against Mama's Enterprises LLC DBA Mama's American Table, for delinquent or deficient taxes or license fees to the extent of the remitted amount of SIXTEEN THOUSAND AND 00/100 DOLLARS (\$16,000.00) for the taxing period of June 2012 through January 2013. The City of Huntsville, Alabama, retains any claim it may have against Mama's Enterprises LLC DBA Mama's American Table, for delinquent or deficient taxes or license fees greater than the amount of SIXTEEN THOUSAND AND 00/100 DOLLARS (\$16,000.00) received from Platte River Insurance Company for the taxing period of June 2012 through January 2013.
