

**ORDINANCE NO. 13-792**

**BE IT ORDAINED** by the City Council of the City of Huntsville, Alabama, that the authorized strength of the City of Huntsville, as determined by Budget Ordinance No. 13-630, adopted and approved on September 26, 2013, is hereby amended as follows:

**Section 1.** The staffing level is hereby increased within Public Works Services by one (1) Public Works Services Assistant, grade 11.

**Section 2.** The staffing level is hereby decreased within Public Works Services by one (1) Secretary II, grade 10.

**Section 3.** The staffing level is hereby increased within Information Technology Services by one (1) System Technician, grade 13.

**Section 4.** The staffing level is hereby decreased within Information Technology Services by one (1) Desktop/Network Technician, grade 10.

**Section 5.** The staffing level is hereby increased within Information Technology Services by one (1) Help Desk Technician, grade 12.

**Section 6.** The staffing level is hereby decreased within Information Technology Services by one (1) Information Technology Coordinator, grade 12.

**Section 7.** The staffing level is hereby increased within Planning by one (1) Secretary II, grade 10.

**Section 8.** The staffing level is hereby decreased within Planning by one (1) Secretary I, grade 7.

**Section 9.** The staffing level is hereby increased within Public Works Services by one (1) Construction & Facilities Maintenance Worker, grade 12.

**Section 10.** The staffing level is hereby decreased within Public Works Services by one (1) Equipment Operator III, grade 10.

**Section 11.** The staffing level is hereby increased within Engineering by one (1) Urban Development Administrative Aide, grade 12.

**Section 12.** The staffing level is hereby decreased within Engineering by one (1) Secretary II, grade 10.

**Section 13.** The staffing level is hereby increased within Water Pollution Control by one (1) Water Pollution Control Administrative Aide, grade 12.

**Section 14.** The staffing level is hereby decreased within Water Pollution Control by one (1) Secretary II, grade 10.

**Section 15.** The staffing level is hereby increased within Parks & Recreation by two (2) Aquatic Activities Coordinator, grade 10.

**Section 16.** The staffing level is hereby decreased within Parks & Recreation by two (2) Swimming Activities Coordinator, grade 10.

**Section 17.** The staffing level is hereby increased within Fleet Services by one (1) Equipment Services Worker II, grade 10.

**Section 18.** The staffing level is hereby decreased within Fleet Services by one (1) Equipment Operator III, grade 10.

**Section 19.** The staffing level is hereby increased within General Services by one (1) General Services Support Clerk, grade 9.

**Section 20.** The staffing level is hereby decreased within General Services by one (1) General Clerk III, grade 7.

**Section 21.** In all other respects, Ordinance No. 89-79, as amended, shall remain in full force and effect.
