**RESOLUTION NO.: 14-**

**WHEREAS**, the Director of the Community Development Division of the City of Huntsville, Alabama ("Director") has reported in his *Report and Affidavit*, a copy of which is attached hereto and incorporated herein by reference, that upon and/or in front of the following described property there exists certain conditions as those enumerated in Acts 1971, Reg. Sess., No. 71-1320, p. 2269, § 2, which conditions constitute a public nuisance:

**1410 Cavalry St., NW, Lots number 25 and 26 in Block Number 6 in Wells Second Addition to the City of Huntsville, Alabama, according to the plat of said Addition, of record in the Office of the Judge of Probate of Madison County, Alabama in Plat Book 1, Page 115; and**

**WHEREAS**, the *Report and Affidavit* of the Director proves to the satisfaction of the City Council that the conditions that exist upon and/or in front of the referenced property constitute a public nuisance in accordance with Acts 1971, Reg. Sess., No. 71-1320, p. 2269.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Huntsville, Alabama, ("City Council") as follows:

1. That, in accordance with Acts 1971, Reg. Sess., No. 71-1320, p. 2269, the conditions as described in the Director's *Report and Affidavit* existing upon and/or in front of the following described property:

**1410 Cavalry St., NW, Lots number 25 and 26 in Block Number 6 in Wells Second Addition to the City of Huntsville, Alabama, according to the plat of said Addition, of record in the Office of the Judge of Probate of Madison County, Alabama in Plat Book 1, Page 115**

are found and hereby declared to be a public nuisance, which must be abated by the removal of said public nuisance.

2. That a meeting of the City Council shall be held at **6:00 p.m., on the 27<sup>th</sup> day of February, 2014**, in the City Council Chambers in the Municipal Building of the City of Huntsville, Alabama, in order to hear and consider all objections or protests, if any, to the proposed removal of said nuisance.

3. The Director is hereby appointed to cause to be conspicuously posted in front of the property on which or in front of which the aforesaid nuisance exists, at not more than 100 feet in distance apart, but not less than 2 in all, notices headed, "Notice to Remove Public Nuisance," such heading to be in words not less than 1 inch in height and substantially in the following form:

Notice is Hereby given that on the *13th day of February, 2014*, the City Council of the City of Huntsville, Alabama, passed a resolution declaring that a public nuisance exists upon and/or in front of the property at **1410 Cavalry St., NW** in said City of Huntsville, Alabama, and more particularly described in said resolution, and that the same constitutes a public nuisance which must be abated by the removal of said public nuisance, otherwise they will be removed and the nuisance will be abated by the municipal authorities, in which case the cost of such

1. That, in accordance with Acts 1971, Reg. Sess., No. 71-1320, p. 2269, the conditions as described in the Director's *Report and Affidavit* existing upon and/or in front of the following described property:

**1410 Cavalry St., NW, Lots number 25 and 26 in Block Number 6 in Wells Second Addition to the City of Huntsville, Alabama, according to the plat of said Addition, of record in the Office of the Judge of Probate of Madison County, Alabama in Plat Book 1, Page 115**

are found and hereby declared to be a public nuisance, which must be abated by the removal of said public nuisance.

2. That a meeting of the City Council shall be held at **6:00 p.m., on the 27<sup>th</sup> day of February, 2014**, in the City Council Chambers in the Municipal Building of the City of Huntsville, Alabama, in order to hear and consider all objections or protests, if any, to the proposed removal of said nuisance.

3. The Director is hereby appointed to cause to be conspicuously posted in front of the property on which or in front of which the aforesaid nuisance exists, at not more than 100 feet in distance apart, but not less than 2 in all, notices headed, "Notice to Remove Public Nuisance," such heading to be in words not less than 1 inch in height and substantially in the following form:

**NOTICE TO REMOVE PUBLIC NUISANCE**

Notice is Hereby given that on the *13th day of February, 2014*, the City Council of the City of Huntsville, Alabama, passed a resolution declaring that a public nuisance exists upon and/or in front of the property at **1410 Cavalry St., NW** in said City of Huntsville, Alabama, and more particularly described in said resolution, and that the same constitutes a public nuisance which must be abated by the removal of said public nuisance, otherwise they will be removed and the nuisance will be abated by the municipal authorities, in which case the cost of such

removal shall be assessed upon the lots and lands from which and/or in front of which such public nuisance is removed, and such cost will constitute a lien upon such lots or lands until paid. Reference is hereby made to said resolution for further particulars.

All property owners having any objections to the proposed removal of said public nuisance are hereby notified to attend a meeting of the City Council of the City of Huntsville, Alabama, to be held at **6:00 p.m., on the 27th day of February, 2014**, in the City Council Chambers in the Municipal Building of the City of Huntsville, Alabama, when their objections will be heard and given due consideration.

2. My current title is Director of the Community Development Division of the City of Huntsville, Alabama ("city").
