

ORDINANCE NO. 14-85

WHEREAS, Ray L. Pickrell and Alice Pickrell have petitioned the governing body of the City of Huntsville, Alabama, requesting that certain property or territory be annexed to the City of Huntsville, Alabama; and

WHEREAS, said petition contained the signatures of the owners of the property as the same is assessed for ad valorem tax purposes; and

WHEREAS, said property is contiguous to the present city limits of the City of Huntsville, Alabama, and does not lie within the corporate limits of any other municipality; and

WHEREAS, a map of said territory showing its relationship to the corporate limits of the City of Huntsville, Alabama, has been filed with the City Clerk-Treasurer; and

WHEREAS, it is the judgement and opinion of the City Council of the City of Huntsville, Alabama, that it is necessary and proper and in the public interest that said property be brought within the corporate limits of the City of Huntsville, Alabama;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, as follows;

1. That the City Council of the City of Huntsville, Alabama hereby assents to the annexation of certain property to the City of Huntsville, Alabama, which said property as hereinabove referenced is more particularly described as follows:

All that part of the Southeast Quarter of Section 22, Township 3 South, Range 2 West, of the Huntsville Meridian, Madison County, Alabama, more particularly described as beginning at a point located at the southeast corner of Lot 6, Block 2 of Putman Acres, Second Addition, as recorded in the Office of the Judge of Probate of Madison County, Alabama, Plat Book 10, Page 100 and Plat Book 11, Page 47; said point is further described as being located on the west right-of-way of Christopher Drive; thence from the point of beginning and leaving said right-of-way North 88 degrees 20 minutes 16 seconds West 820.92 feet to a point located at the southwest corner of said Lot 6; thence North 01 degrees 31 minutes 07 seconds East 163.58 feet to a point located at the northwest corner of said Lot 6; said point is further described as being located on the existing corporate limits of the City of Huntsville; thence South 88 degrees 18 minutes 56 seconds East 819.29 feet to a point located at the northeast corner of said Lot 6; said point is further described as being located on the west right-of-way of Christopher Drive; thence leaving the existing corporate limits and along said right-of-way South 00 degrees 58 minutes 52 seconds West 165.44 feet to the point of beginning and containing 3.10 acres, more or less.

2. That the corporate limits of the City of Huntsville, Alabama, are hereby extended and rearranged so as to embrace and include the hereinafter property as part of the corporate area of the City of Huntsville.

3. That this ordinance shall become effective upon its publication as required by law.

4. That the Mayor and City Clerk-Treasurer of the City of Huntsville, Alabama, are hereby authorized, requested and directed for and on behalf of the governing body of the City to file a description of the property or territory herein annexed in the Judge of Probate Office of Madison County.
