**AGREEMENT BETWEEN THE CITY OF HUNTSVILLE
AND VEENA KAUL**

THIS AGREEMENT is made and entered into on the 27th day of February, 2014, by and between Veena Kaul, an individual, ("Kaul") and the City of Huntsville, Alabama, a municipal corporation in the State of Alabama ("City"),

WITNESSETH:

In consideration of the mutual promises and covenants herein contained, the parties do hereby agree as follows, to wit:

1. Kaul shall be employed by the City of Huntsville as an Accountant III, working as a Tax Auditor in the Finance Department.
2. Kaul is hereby employed as a special employee of the City, working on a part-time basis, and as such, shall have no authorization to incur any debt or obligation on behalf of the City, and shall not be entitled to any benefits of any kind while working for the City. During the term of this agreement, Kaul shall report to the Tax Audit Supervisor.
3. The term of this contract shall be for a period of one (1) year commencing on February 28, 2014.
4. This contract may be terminated by either party upon thirty (30) days written notice being provided to the other party.
5. During the term of this contract, Kaul shall work when requested by her supervisor and shall be paid an hourly rate of \$31.40 for not more than 28 hours per week, not to exceed \$23,000 per year.
6. The City shall provide Kaul a parking space during work hours at a location determined by the City's Director of Parking and Public Transit.

7. Kaul shall be responsible for maintaining automobile liability insurance on any vehicle owned or leased by her and used while performing services for City with minimum limits of \$100,000 for personal injury; \$100,000 property damage; and \$300,000 per occurrence.

8. Kaul acknowledges that confidential information may be made available to her in connection with her work pursuant to this agreement. Kaul agrees not to disclose the confidential information to any third party at any time following execution of this agreement. This clause shall survive the termination of this Agreement.

9. This agreement constitutes the entire agreement between the parties.
