

ORDINANCE NO. 14- 365

**BE IT ORDAINED** by the City Council of the City of Huntsville, Alabama, that Ordinance No. 89-79, as amended, entitled the City of Huntsville Classification and Salary Plan, be and the same is hereby further amended as follows:

**Section 1.** The position of Cemetery Operations Specialist, classified at a salary grade 15, is hereby renamed Cemetery Operations Supervisor, classified at a salary grade 17.

**Section 2.** The position of Landscape Maintenance Project Supervisor, classified at a salary grade 12, is hereby reclassified to a salary grade 13.

**Section 3.** The position of Municipal Court Office Assistant, classified at a salary grade 11, is hereby renamed Municipal Court Administrative Aide, classified at a salary grade 12.

**Section 4.** The position of Revenue License Inspector Supervisor, classified at a salary grade 16, is hereby reclassified to a salary grade 17.

**Section 5.** The position of Landscape Management Superintendent, classified at a salary grade 18, is hereby renamed Manager of Landscape Management, classified at a salary grade 19.

**Section 6.** The position of Community Service Supervisor is hereby created at a salary grade 10.

**Section 7.** In all other respects, Ordinance No. 89-79, as amended, shall remain in full force and effect.


