

ORDINANCE NO. 14-\_\_\_\_\_

BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, as follows:

Section 1. The City Council of the City of Huntsville, Alabama, finds that an application has been presented to the City of Huntsville requesting a vacation of a portion of a 10-foot utility and drainage easement; that the applicants have represented to the City of Huntsville that Armondo Cioppi and wife, Evelina Cioppi, are the owners of the property across which said easement lies; that said easement, or portion being vacated, is not presently used and is no longer needed for a public or municipal purpose.

Section 2. Pursuant to the findings in Section 1 hereinabove, the Mayor of the City of Huntsville, Alabama, is hereby authorized, requested and directed to execute a quitclaim deed vacating the easement hereinafter described, said deed being substantially in words and figures as follows, to-wit:

All that part of Lot 9, according to the plat of survey of Park Hampton Subdivision a Resubdivision of Lot 1 of Park Hampton Subdivision (Document No. 20100112000019580) as recorded in Document No. 201011300000692960, in the Office of the Judge of Probate of Madison County, Alabama. Particularly described as commencing at the Northwest corner of said Lot 9. Thence South 89 degrees 13 minutes 25 seconds East 5.00 feet; Thence South 00 degrees 46 minutes 35 seconds West 5.00 feet to the point of beginning of the herein described parcel.

Thence from the point of beginning, South 89 degrees 13 minutes 25 seconds East 5.00 feet; Thence South 00 degrees 46 minutes 35 seconds West 80.00 feet; Thence North 89 degrees 13 minutes 25 seconds West 5.00 feet; Thence North 00 degrees 46 minutes 35 seconds East 80.00 feet to the point of beginning.
