ORDINANCE NO. 14 - \_\_\_\_\_

BE IT ORDAINED by the City Council of the City of Huntsville, Alabama, that Chapter 8, Article 4, Section 8, Division 4 Taximeters and Rates of the Code of Ordinances of the City of Huntsville, as amended, is hereby further amended to read as follows:

CHAPTER 8

ARTICLE 4

TAXICABS AND LIMOUSINES

DIVISION 4. - TAXIMETERS AND RATES

Sec. 8-277. AMOUNTS CHARGED

(a) The maximum rate to be charged for a trip to one destination by any taxicab shall be \$3.50 for the first one-half-mile and \$0.10 for each additional one-twentieth mile (\$3.50 for the first one-half-mile and \$2.00 for each mile thereafter.)

(1) A fuel surcharge may be added to the meter drop rate (first one-half-mile rate) under the following conditions. If the average retail fuel price for regular grade gasoline in the City of Huntsville is greater than \$4.00 per gallon, \$1.00 may be added to the drop rate currently authorized. If the average retail price for regular grade gasoline in the City of Huntsville is greater than \$5.00 per gallon, \$1.00 may be added to the drop rate currently authorized.
