

ORDINANCE NO. 14 - _____

WHEREAS, the City Council of the City of Huntsville has determined that the property described below has been identified by Public Transit as surplus to the needs of the City of Huntsville and is no longer needed for a public or municipal purpose by the City of Huntsville.

THEREFORE BE IT ORDAINED, by the City Council of the City of Huntsville, Alabama that the vehicle described below is surplus to the needs of the City of Huntsville and no longer needed for a public or municipal purpose by the City of Huntsville.

BE IT FURTHER ORDAINED that the MAYOR and City Clerk-Treasurer be, and they are hereby, authorized and directed to dispose of said vehicle owned by the City of Huntsville, Alabama, described below, by selling such property via auction, Fowler Auction and Real Estate Service, Inc. All such property shall be sold to the highest bidder. The Mayor and the City Clerk-Treasurer be, and they are hereby, authorized and directed to execute and attest, respectively, for and on behalf of the City of Huntsville, Alabama; and signed by the Mayor, conveyance of the title to said vehicle, when applicable. All proceeds of which will be deposited into the City of Huntsville Public Transit general revenue account 01-8700-3098-3410.
