THIS MODIFICATION NO. 1 IS MADE TO THE AGREEMENT entitled "Agreement between the City of Huntsville, Alabama and Family Services Center, Inc., for the use of FY13 Emergency Solutions Grant funds" as referenced above and is entered into on this the 12th day of January, 2015 by and between the City of Huntsville, Alabama (City) and Family Services Center, Inc. (Agency).

WITNESSETH

WHEREAS, the City and the Agency previously entered into an agreement for the City to provide FY13 Emergency Solutions Grant (ESG) funds to the Agency for use according to ESG guidelines; and

WHEREAS, the said agreement was adopted and approved by the Huntsville City Council on December 5, 2013, pursuant to Resolution No. 13-990; and

WHEREAS the CITY has demonstrated the necessity to amend the Cost Category (budget) as described in the agreement.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to modify the Agreement as follows:

The service of the Agency shall be undertaken beginning on December 5, 2013 and be completed by March 31, 2015. All funds must be obligated, expended and the matching requirement met by March 31, 2015.
