RESOLUTION NO. 15 - \_\_\_\_\_

BE IT RESOLVED by the City Council of the City of Huntsville, Alabama, as follows:

1. That the City Council of the City of Huntsville, Alabama, proposes creation of a tax increment district, tentatively named Tax Increment Financing District 6 ("TIF D6"), pursuant to Ala. Code §§ 11-99-1 et seq. Furthermore, Ala. Code § 11-99-4(2) requires the City of Huntsville to call a meeting of the designated representatives of each deferred tax recipient governing body to discuss issues related to the creation of the proposed tax increment district.

2. That the City Council of the City of Huntsville, Alabama, shall meet in a Special Session at 5:00 p.m. on the 17<sup>th</sup> day of August, 2015, in the Council Chambers of the City of Huntsville, Alabama, located at 308 Fountain Circle, Huntsville, Alabama, for the purpose of meeting with the designated representatives of the governing bodies of deferred tax recipients, pursuant to Ala. Code §§ 11-99-2(4), at which date, time and place all interested parties will be afforded a reasonable opportunity to express their views on the boundaries of the tax increment financing, development within such district, the exclusion of particular parcels of property from such district, and tax collection for such district.
