**WHEREAS**, the Planning Commission of the City of Huntsville, Alabama, has given consideration to an amendment to the Zoning Ordinance, a synopsis of said amendment being as follows:

- (1) Deletes ARTICLE 21 - NEIGHBORHOOD BUSINESS C-1A DISTRICT REGULATIONS.
- (2) The first publication of this resolution, this synopsis, and the ordinance hereinafter set out at length shall be in the Huntsville Times on the \_\_\_ day of \_\_\_, 2015, and the second publication shall be one week thereafter on the \_\_\_ day of \_\_\_, 2015, both of which publications shall be at least 15 days in advance of the date of the public hearing hereinafter referred to.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Huntsville, Alabama, as follows:

*Section 1. (1) Deletes ARTICLE 21 - NEIGHBORHOOD BUSINESS C-1A DISTRICT REGULATIONS.*
