



The above applications of Sure Save Pharmacy, Hickory House, Wind Mill Beverages, and Deja Vieux were unanimously approved by this Committee.

The applications of Am Booth's Lumberyard and Touchstar Cinema were disapproved by this Committee.

Ms. Janice Roberson was present for the application of the Hickory House.

Mr. Doug Smith and wife, Joy were in attendance for the application of AM Booth's Lumberyard.

Chairman Flory asked for discussion on AM Booth's Lumberyard.

Mr. Cole stated regarding AM Booth's Lumberyard that he and Officer Hollingsworth had gone out to this establishment and paid a visit. They had questions and some were addressed by the Fire Department personnel. He said there are rooms being shared with the Lone Goose, and this is an issue. There are also concerns with the patio area. He further stated once inside the front entrance you can go in several ways to get into the rooms. He said this may have to have blocked access into the main premises since they are using a common area also used by the Lone Goose.

Mr. Smith stated he had been operating this way for sometime and didn't understand what had changed.

Mr. Cole stated then he didn't have a sandwich bar and now he has a special retail license and things under that have changed.

Chairman Flory asked what type of license he previously had, and Mr. Smith said he was never open to the general public. He had food night when the food trucks came over. He thought he could do small concerts but was told he couldn't so he closed this down. He mainly does weddings, fund raisers, Christmas parties with limited invitations.

Officer Hollingsworth stated once you are on the inside it was all special events but now he wants a deli and to get to this space you are in a common area and the ABC Board will not allow this. He suggested he may have to have staffing at the door.

Mr. Smith informed the Committee he won't be selling alcohol in the front part at all. He wants to expand the kitchen and now where there can be 65 people, he wants little tables on the side for 15. He wants to take the wall out and have big coolers for events.

Chairman Flory pointed out this application was submitted in July and he has done nothing regarding the construction yet.

Mr. Smith stated he had very complicated issues with the Fire Department and architectural plans. He has some plans he hasn't submitted but turned in the overall view plans. He wants to get this all done as quickly as possible.

Fire Marshall Wilkerson stated he asked for plans in March. He said he had some preliminary plans to look at but then plans changed and he just got acceptable plans a couple of weeks ago. He said the Engineering Department is looking at it and the Building Department is waiting for a review.

Mr. Smith stated the Lone Goose's lease is up in March and he plans to take that part over for entertainment. He has a train car he bought three years ago, and this establishment is different from everybody else's.

Officer Hollingsworth asked Mr. Smith if he was able to get an agreement on buying the diner?

Chairman Flory stated he had to sell 50% food, and Mr. Smith said that wouldn't be a problem. It will also be non-smoking for children's events.

Chairman Flory stated again no move has really been done, and this has been delayed since July. He stated this Committee can vote today and see how this goes.

Mr. McGuffey asked if Fire Marshall Wilkerson has the authority to go out and close this business down if he doesn't do what he says he will do?

Mr. Cole stated they don't normally okay a license before the Fire Department approves it. If he does what he says on the plans, we are okay with it, but there is still some work to be done.

Chairman Flory asked Mr. Smith if he could continue operating now?

Mr. Smith stated he would not be able to use these spaces and they were hoping this would get them through a slim winter season. He further stated he has new fire doors specially ordered and has every intention of improving the area and making things work, and he's done major clean-up of the property.

Mr. Cole said the license can be approved pending all departments checking off on this.

Mr. Smith told the Committee he had addressed all issues of life safety except the Meridian Street issue.

Officer Hollingsworth said the ABC folks will not let two licensees share a building.

Fire Marshall Wilkerson said normally a license isn't issued until the work is complete and they haven't gone back for another inspection because things aren't corrected. He said the third exit that goes to Meridian Street is a problem and until that exit is fixed, he is limited to only a 250 person capacity.

Officer Hollingsworth asked if he can't do business until he gets a license, could he get a license for corrections?

Mr. McGuffey stated if Fire Marshall Wilkerson can go in the business at any time and close it down, that should be motivation for Mr. Smith to get all this done.

Fire Marshall Wilkerson said since he signed off on the alcohol he's been treated a little differently and Mr. Smith's attitude has changed with issues.

Mr. Smith said he wants to focus on the life saving issues first and submitted plans and everybody said it would work. Then he was told to add a fire wall, replace fire doors and submitted plans for all this. He says he has done what he was told to do.

Fire Marshall Wilkerson stated the plans are in the Inspection Department with Andrea Passeur and will be held for two more weeks.

Mr. Cole asked Mr. Smith if he had renewed his state license for next year? Mr. Smith replied his license will expire October 1, and he has but was told they won't refund any money, and if the license is not used, he can get a refund.

Chairman Flory said they can pass this with no license issued until everything is met or have it approved on the books but he cannot operate.

Mr. Smith says he has events scheduled and closing is best.

Officer Hollingsworth asked if the state liquor license states his license is only for weddings?

Mr. Cole informed him the title designated for the Lumberyard is a banquet hall and our license is good until January 31 of next year. The issue is with the State also.

Fire Marshall Wilkerson said since he is closed now and he can't operate, he can go out in the morning and do an inspection.

Mr. Cole asked Fire Marshall Wilkerson if he can close them down at any time, and his answer was the only business the Fire Marshall has closed down before was because of fire issues.

Chairman Flory stated there are two options: First, it can be approved to operate the way it is now until all is done, or other option is disapprove.

Mr. Cole informed the applicant he has the right to appeal this Committee's decision to the City Council if disapproved.

Mr. Smith stated he is purchasing a new kitchen to add private parties and he can't afford to do all these plans and can't do anything until March of next year.

Mr. Cole stated he could run the restaurant now since he has purchased a license yesterday, but this is without alcohol.

Mr. Smith told the Committee this was asking for a lot. He's been a good citizen and transformed the corner and improved the neighborhood.

Chairman Flory stated it was time to move forward and take a vote. The Clerk's Office disapproved, Michelle in Planning approved, Captain Harris in Police disapproved. The applicant was told he can give a letter to Chairman Flory if he wishes to appeal the decision and it will be placed on the Council agenda for October 8.

Ms. Roberson with the Hickory House was informed by Officer Hollingsworth her background check had been approved, but she is the only person approved, and if the building is open, she has to be in there. He said her brother was denied and can be an employee but not in charge of anything.

Mr. Cole stated Ms. Roberson could hire other managers and she wouldn't have to be on the premises at all times but every manager has to be approved by the Police Department.

Ms. Roberson said probably the bartender will be in charge, and again it was stressed he needs to be checked out by the police.

Mr. McGuffey stated she has to produce 50% food sales. He said the entertainment was karaoke and it can be live entertainment but it has to go through the planning Department and the Board of Adjustment. He thinks this might be active for two more months but anything other than a radio needs approval. Entertainment has to stop at 11:00 o'clock and you must obey the noise ordinance.

Chairman Flory told Ms. Roberson to come see him next Friday for her license.

The application for Touchstar Cinema was disapproved since there is an ordinance that governs movie theaters and nobody under the age of 21 can be in the area per Officer Hollingsworth. The patrons have to be either 21 or above or there has to be a physical barrier. The applicant was asked to return information regarding this and to submit a menu and has done neither.
