RESOLUTION NO. 15-

WHEREAS, the Planning Commission of the City of Huntsville, Alabama, has given consideration to an amendment to the Zoning Ordinance, a synopsis of said amendment being as follows:

- (1) The rezoning of certain lands lying south of Interstate 565 and east of Swancott Road from Highway Business C-4 District to Commercial Industrial Park District.
- (2) The first publication of this resolution, this synopsis, and the ordinance hereinafter set out at length shall be in the Huntsville Times on the _____ day of _____, 2015, and the second publication shall be one week thereafter on the _____ day of _____, 2015, both of which publications shall be at least 15 days in advance of the date of the public hearing hereinafter referred to.

WHEREAS, it is the judgement and opinion of the City Council of the City of Huntsville, Alabama, that consideration should be given to the adoption of an amendment to the Zoning Ordinance of the City of Huntsville, Alabama, in accordance with said request;

NOW, THEREFORE, **BE IT RESOLVED** by the City Council of the City of Huntsville, Alabama, as follows:

1. That the City Council of the City of Huntsville, Alabama, shall meet at 6:00 p.m. on the _____ day of _____, 2015, in the Council Chambers of the City of Huntsville Administration Building at 308 Fountain Circle in the City of Huntsville, Alabama, for the purpose of holding a public hearing at which time and place all persons, parties in interest and cities who desire, shall have an opportunity to be heard in opposition to or in favor of said ordinance amending the Zoning Ordinance of the City of Huntsville, Alabama.

2. That the proposed amendment to the Zoning Ordinance of the City of Huntsville, Alabama, is substantially in words and figures as follows:

ORDINANCE NO. 15-

AN ORDINANCE TO AMEND THE ZONING ORDINANCES OF THE
CITY OF HUNTSVILLE, ALABAMA

The public welfare requiring it, and under authority granted by Section 11-52-78 of the 1975 Code of Alabama, **BE IT ORDAINED** by the City Council for the City of Huntsville, Alabama, as follows:

1. That the following area, lying south of Interstate 565 and east of Swancott Road, which area is now shown and classified on the Official Zoning Maps of the City of Huntsville, Alabama, as Highway Business C-4 District shall be shown and classified on the Official Zoning Maps of the City of Huntsville, Alabama, as Commercial Industrial Park District, in the Zoning Ordinances of the City of Huntsville, Alabama, said property being particularly described as follows:

All that part of Section 34, Township 4 South, Range 3 West and Section 3, Township 5 South, Range 3 West, of the Huntsville Meridian, in the City of Huntsville, Madison County, Alabama, more particularly described as beginning at a point located at the southeast corner of said Section 34; thence from the point of beginning and along the south boundary of said Section 34 Due West 709.23 feet to the point of true beginning; thence from the point of true beginning and leaving said boundary South 01 degrees 20 minutes 49 seconds West 847.18 feet; thence North 88 degrees 52 minutes 01 seconds West 449.96 feet; thence South 01 degrees 38 minutes 16 seconds West 674.77 feet; thence South 34 degrees 54 minutes 36 seconds West 1,310.56 feet; thence North 88 degrees 52 minutes 01 seconds West 833.05 feet; thence North 01 degrees 07 minutes 59 seconds West 1,001.82 feet; thence North 01 degrees 24 minutes 14 seconds West 1,611.32 feet; thence Due West 63.03 feet; thence North 00 degrees 21 minutes 42 seconds East 1,067.85 feet to a point located on the centerline of Interstate 565; thence along said centerline North 67 degrees 33 minutes 29 seconds East 100.00 feet; thence leaving said centerline South 00 degrees 06 minutes 15 seconds East 1,107.67 feet; thence Due East 2,053.91 feet to the point of true beginning and containing 96.32 acres, more or less.

ORDINANCE NO. 15-

2. The boundaries of the above district as described and defined above are hereby established and shall be shown on the Official Zoning Maps of the City of Huntsville, Alabama, on file in the Planning Division of the Urban Development Department, in accordance with the various classifications herein enumerated and hereafter the regulations governing said district under the Zoning Ordinance of the City of Huntsville, Alabama, shall apply to the area so described.

3. This ordinance shall take effect from and after the date of publication.
