



MODIFICATION NO. 1

THIS MODIFICATION IS MADE TO THE AGREEMENT entitled "Agreement between the City of Huntsville, Alabama and North Alabama Coalition for the Homeless (NACH), Inc.," as referenced above and is entered into on this the 11th day of February, 2016 by and between the City of Huntsville, Alabama (City) and North Alabama Coalition for the Homeless (NACH), Inc.(Agency).

WITNESSETH

WHEREAS the Agency has indicated a need to amend their Time of Performance.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereby agree to modify the Agreement as follows:

1. Effective February 11, 2016 the Time of Performance set forth in Section IV, Page 2 of the Agreement is deleted and replaced with the following:

TIME OF PERFORMANCE-The service of the Agency shall be undertaken beginning on January 1, 2016 and be completed by December 31, 2016. All funds must be obligated, expended and the matching requirement met by March 31, 2016.

2. All other terms and conditions of the Original Agreement remain unchanged and in full force and effect.
