




**AGREEMENT BETWEEN THE
CITY OF HUNTSVILLE AND
THE ROCKET CITY CHAIN GANG**

AGREEMENT

THIS AGREEMENT, made and entered into this 25th day of February, 2016, by and between the Rocket City Chain Gang, an unincorporated association, hereinafter referred to as "Organization", and the City of Huntsville, a municipal corporation in the State of Alabama, hereinafter referred to as "CITY".

WITNESSETH:

WHEREAS, the Organization was formed in 1982 and promotes the sport of disc golf in Huntsville; and,

WHEREAS, the Organization has previously donated money to the City for the purpose of constructing and maintaining public disc golf courses in Huntsville city parks; and,

WHEREAS, the baskets at the disc golf course at Brahan Spring Park are in need of replacement; and,

WHEREAS, the Organization is willing to raise funds for new baskets; and

WHEREAS, the Organization desires to sell the old baskets in an auction to raise funds for the new baskets;

NOW, THEREFORE, for and in consideration of the mutual promises and covenants contained herein, the parties agree as follows:

1. City agrees to donate the old baskets at the Brahan Spring disc golf course, which have been previously declared surplus, to the Organization in exchange for the Organization providing funding for new baskets for the course (\$7,782.28 estimated value).

2. The parties agree that the services provided by the Organization serve a legitimate public purpose.

3. The Organization agrees that it has no authority to obligate any City funds or equipment beyond those donated by the City for this agreement.
