BE IT RESOLVED by the City Council of the City of Huntsville, Alabama, that the Mayor be, and he is hereby authorized to enter into a License Agreement by and between the City of Huntsville and Alonzo Burwell, on behalf of the City of Huntsville, a municipal corporation in the State of Alabama, which said License Agreement is substantially in words and figures as that certain document attached hereto and identified as "License Agreement between the City of Huntsville and Alonzo Burwell", and consisting of three (3) pages including Exhibit "A", and the date of July 14, 2016, appearing on the margin of the first page, together with the signature of the President of the City Council, and an executed copy of said document after being permanently kept on file in the Office of the City Clerk-Treasurer of the City of Huntsville, Alabama.

LICENSE AGREEMENT

THIS AGREEMENT made, entered into and executed by and between THE CITY OF HUNTSVILLE, a municipal corporation in the State of Alabama, hereinafter called the "Licensor", and ALONZO BURWELL, hereinafter called the "Licensee".

RECITALS

Licensor is the owner of the lands described in Exhibit A attached hereto, which said real property is situated in the City of Huntsville, Alabama, hereinafter referred to as the "Property".

Licensee desires to exercise certain rights and privileges upon the above-described property and Licensor has agreed, upon certain terms and conditions, to grant the requested rights and privileges.

AGREEMENT

THE PREMISES CONSIDERED and in consideration of the rights and privileges herein granted and the sum to be paid Licensor, as hereinafter set forth, the parties hereto agree as follows:

Rights and Privileges: Licensor hereby grants to Licensee the right and privilege to enter upon the property at any and all times, and to cut, harvest and remove hay from the Property.

Duration of License: The License hereby granted shall become effective as of the 15th day of July, 2016, and continue in full force and effect until December 31, 2016. (The Termination Date).

License Fee: The Property consists of approximately one hundred (100) acres. Licensee expects to obtain usable hay from approximately 80 acres. In exchange for being permitted to harvest and keep all such usable hay, Licensee covenants and agrees to cut all weeds, brush and undergrowth from the entire property. The cutting of weeds, brush and undergrowth shall be accepted by Licensor as compensation in lieu of a License Fee.

Inspection - Acceptance: Licensee acknowledges that he has conducted such inspections, testing and investigations as he has deemed necessary and has determined that the property is in an acceptable condition for his intended use thereof.

Indemnification: Licensee will hold and save Licensor harmless from any and all damages, costs and expenses on account of any acts or omissions of Licensee or any agent, employer or invitee of the Licenses.

Licensee not Lessee: No legal title or leasehold interest in the above described premises or appurtenances thereto shall be deemed or construed to have been created or vested in the Licensee by anything contained herein.

Termination of Occupancy: Licensee shall, on or before the Termination Date, quietly and peaceably remove himself and his personal properties from the Property.




