WHEREAS, an application has been made by **Cecilio A. Kentish, Jr./dba Orbit's Super Shuttle, LLC** for a certification of public convenience and necessity for the operation of an airport shuttle in the City of Huntsville, and

WHEREAS, Ordinance No. 75-243 provides for the publication of a notice that such application has been made and setting a date for a public hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Huntsville, Alabama, as follows:

1. That the intent of the City Council of the City of Huntsville, Alabama to consider whether a public convenience and necessity justifies the issuance of an airport shuttle license to **Cecilio A. Kentish, Jr./dba Orbit's Super Shuttle, LLC** for the operation of an airport shuttle is hereby declared.
2. That the City Council of the City of Huntsville shall meet at 6:00 P.M. on the 11th day of August, 2016, at the Council Hall or at such other place announced by the Council in the City of Huntsville for the purpose of holding a public hearing on the question of whether public convenience and necessity justifies the issuance of an airport shuttle license to **Cecilio A. Kentish, Jr./dba Orbit's Super Shuttle, LLC** the operation of an airport shuttle, at which time all parties may appear in person, by agent, or by attorney for the purpose of voicing objections or remonstrations.
3. That this resolution shall be published in the Huntsville Times, a newspaper of general circulation within the City of Huntsville, Alabama, said publication to be not less than seven days prior to the date of this hearing.
