## **AGREEMENT**

THIS AGREEMENT is entered into on this the 11th day of April, 2013, by and between the CITY OF HUNTSVILLE, ALABAMA, a municipal corporation in the State of Alabama, doing business as the HUNTSVILLE-MADSION COUNTY EMERGENCY MANAGEMENT AGENCY ("EMA") and the NORTH ALABAMA MEDICAL RESERVE CORPS.

## WITNESSETH

WHEREAS EMA has received a grant accepted by the City of Huntsville by adoption of Resolution No. 11-944 (1MMR) on December 15, 2011 and is the administrator of the grant in the amounts of \$281,693.00 from the Alabama Department of Homeland Security, said funds to be used to provide for the funding of the Metropolitan Medical Response System. And

WHEREAS the NORTH ALABAMA MEDICAL RESERVE CORPS has the expertise and the staff to establish the Medical Reserve Corps for the benefit of all the citizens of Madison County, Alabama;

**NOW THEREFORE,** for and in consideration of the promises and mutual covenants hereinafter set forth, and for other good and valuable consideration hereinafter provided, the parties do hereby agree as follows:

1.	The NORTH A	ALABAMA	MEDICAL	RESERVE	CORPS	shall

- 2. Invoices for the expenses incurred shall be furnished to the Director of the Huntsville-Madison County Emergency Management Agency on a monthly basis, so that EMA can reimburse The NORTH ALABAMA MEDICAL RESERVE CORPS for the expenses. Reimbursement to be made within a reasonable period of time (usually not to exceed 10 days).
- 3. The NORTH ALABAMA MEDICAL RESERVE CORPS agrees to assist and cooperate with EMA in providing all documentation required by the Alabama Department of Homeland Security to ensure compliance with the terms and conditions of the above referenced Alabama Department of Homeland Security Grant to the Huntsville-Madison County Emergency Management Agency.
- 4. The NORTH ALABAMA MEDICAL RESERVE CORPS shall complete all expenditures under this agreement and submit all invoices therefore no later than the end of the grant period (including extensions).
- 5. This Agreement shall be governed and construed in accordance with the laws of the State of Alabama.
- 6. This Agreement contains the entire agreement of the parties and there are no other promises or conditions whether oral or written. This Agreement supersedes any prior written or oral agreements between the parties.
- 7. This Agreement may be modified or amended if the amendment is made in writing and is signed by both parties.
- 8. If any provision of this Agreement shall be held to be invalid or unenforceable for any reason, the remaining provisions shall continue to be valid and enforceable. If a Court finds that any provision of the Agreement is invalid or unenforceable, but that by limiting such provision it would become valid and enforceable, then such provision shall be deemed to be written, construed, and enforced as so limited.
- 9. The failure of either party to enforce any provision of this Agreement shall not be construed as a waiver or limitation of that party's right to subsequently enforce and compel strict compliance with every provision of this Agreement.
  - 10. This Agreement shall become effective on the effective date of the grant (1MMR) and end at the expiration of the respective grants (including extensions).
  - 11. Nothing contained herein shall create a contractual relationship with, or any rights in favor of, any third party.
