- 1. Reed Contracting Services, Inc. will provide for renewal of contract for an additional one (1) year with services provided on an as-needed basis with up to the Not-to-Exceed (NTE) Amount per Paragraph 5 on Page 1 of Attachment B of the original contract which was adopted by Resolution No. 13-449 of June 13, 2013.
- 2. Item #1 shall be performed in accordance with the original agreement dated June 13, 2013, and approved by the City Council by Resolution No. 13-449.
- 3. The terms of this contract modification and the execution thereof is not in any way to be viewed as a waiver on the part of the Owner of any of its rights pursuant to the Contract.
- All other terms and conditions remain unchanged.
