

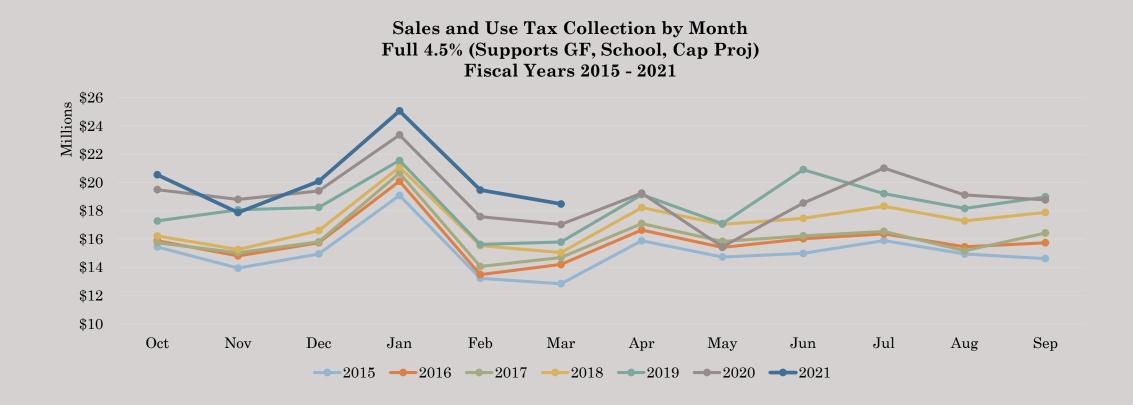

FY2021 Revenues – Other General Fund

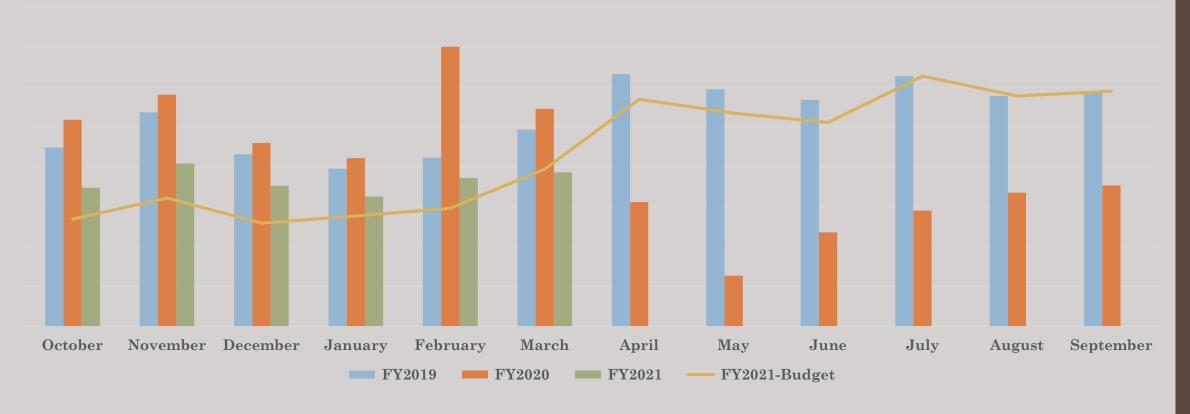

SECTION 1. SHORT TITLE.
